2	If preservatives, additives and colours are used in preserved food, its level and details shall be mentioned and shall not be labelled separately but embossed.	
3	Any raw materials used in the preparation of food and beverages, which become unusable after a certain period, the date of production and expiry date shall be written or printed on the container or package of that goods.	
4	No radioactivity test shall be required for import of spices.
