| 2 | No fish and fish products prohibited by any provisions under this Act or any other act, order or rules or any fish and fish products rotten, contaminated, containing harmful chemicals, mixed with adulterants and harmful substances shall be imported. | Sec. 22(1), FIQC Act, 2020 [Bangla] |
| 3 | Production and expiry date shall be clearly embossed on each container or package; not on the container or package by labelling it separately. Expired food items cannot be imported. | Article 23(19), IPO 2021-24 [Bangla] |
| 4 | If preservatives, additives and colours are used in preserved food, its label and details shall be embossed on the container, label not to be pasted separately. | Article 23(21), IPO 2021-24 [Bangla] |
