2	Maximum acceptable radioactivity limit of milk and dairy products shall be 95 bq of Cesium-137 per kilogram and the maximum acceptable radioactivity limit for other food items shall be 50 bq of Cesium-137 per kilogram	Article 23(15), IPO 2021-24 [<u>Bangla]</u>
